Singapore Integral to India's 'Act East' Policy: PM Modi

Prime Minister Narendra Modi emphasized Singapore's crucial role in India's 'Act East' policy, stating India aims to replicate Singapore-like success stories within its territory. During his visit to Singapore, Mr. Modi met Singaporean Prime Minister Lawrence Wong and oversaw the signing of including key agreements, an MoU semiconductors strengthen to supply chain resilience.

6 MAOISTS WERE KILLED IN A GUNFIGHT WITH POLICE IN TELANGANA

INTERNAL SECURITY



Bhadradri Kothagudem, Telangana: In a significant blow to the Communist Party of India (Maoist), six of its cadres were killed in an encounter with police forces in the early hours of Thursday. The incident occurred near Mothe village in Bhadradri Kothagudem district.

The encounter took place around 6:45 AM when a police patrol team came across a group of Maoists in the forest area. A gunfight ensued, resulting in the deaths of six Maoists. Five weapons, including two AK-47 rifles, an SLR, a .303 rifle, and a pistol, were recovered from the site along with ammunition and other materials.

Two policemen from the Greyhounds, the anti-naxal force of the Telangana police, sustained injuries during the encounter and were immediately rushed to a hospital. Their condition is reported to be stable.

The incident is a setback for the Maoists, who have been attempting to reestablish their presence in the Karakagudem region, once a stronghold of the outfit. Sources believe that Lachanna, the secretary of the CPI (Maoist) Manuguru Area Committee, may have been killed in the encounter.

NO FRICTION BETWEEN CENTRE, STATES ON GST FRONT, SAYS FINANCE MINISTER

Union Finance Minister Nirmala Sitharaman dismissed claims by Opposition leaders about friction between the Centre and States over Goods and Services Tax (GST). Speaking at an event in Chennai organized by the Revenue Bar Association, she emphasized the collaborative nature of GST Council meetings, where Finance Ministers from various political parties work together to simplify and rationalize GST rates.

Collaboration in Revenue Generation

Sitharaman stressed the importance of respecting the federal structure in ensuring effective revenue generation. She highlighted that the Centre and States must work together not only in development activities but also in widening the tax base. She denied any friction, stating that discussions in GST Council meetings focus on tax simplification, rationalization, and compliance ease.

Commitment to Simplifying GST

The Finance Minister reaffirmed the government's commitment to simplifying tax compliance and reducing the GST burden where possible. She noted that the average GST rate had dropped to 12.2% in 2023 from a revenue-neutral rate of 15.3% in 2017.

Not a Burden on Consumers

Sitharaman emphasized that GST is not a burden on common people, with nearly 60% of consumer goods attracting a GST rate of 5% or less. The Group of Ministers (GoM) continues to explore further rate reductions and rationalization.

PAC TO REVIEW REGULATORY BODIES AND INFRASTRUCTURE CHARGES

- **4. Overall Objective:** Through these reviews, the PAC aims to assess the effectiveness of regulatory bodies and ensure the equitable distribution of burdens related to public infrastructure usage.

The 15th Finance Commission had noted that India has had a larger, and rising, vertical fiscal imbalance (VFI) than most other federations

THE GIST

As the 15th Finance Commission noted, States incur 61% of the revenue expenditure but collect only 38% of the revenue receipts. In short, the ability of the States to incur expenditures is dependent on transfers from the Union government.

The problem of VFI falls under the purview of the Finance Commission. Many States have raised the demand that the share of tax devolution from the net proceeds must be fixed at 50% by the 16th Finance Commission.

VERTICAL FISCAL IMBALANCE IN INDIA: A CHALLENGE FOR THE 16TH FINANCE COMMISSION

The Problem of VFI

India's federal system suffers from Vertical Fiscal Imbalance (VFI), where States incur more expenditures than they can generate in revenue. This imbalance has been exacerbated by the concentration of revenue with the Union government.

The Role of the Finance Commission

The Finance Commission is tasked with addressing VFI by distributing taxes between the Union and State governments. The 15th Finance Commission noted the need to reduce VFI and recommended a share of tax devolution from net proceeds.

Calculating VFI

To estimate VFI, we calculate the ratio of States' Own Revenue Receipts (ORR) and tax devolution to their Own Revenue Expenditure (ORE). A ratio less than 1 indicates a VFI deficit.

The Demand for Increased Tax Devolution

Many States have demanded a 50% share of tax devolution from net proceeds. This demand is supported by our analysis, which suggests that a 49% share is necessary to eliminate VFI, given current expenditure levels.

Conclusion

Addressing VFI is crucial for a healthy fiscal federalism. The 16th Finance Commission must consider increasing tax devolution to empower States and improve the efficiency of public spending.

CAN KERALA ACCESS FUNDS FROM THE LOSS AND DAMAGE FUND?

THE GIST

- The Loss and Damage Fund (LDF) was established at the 2022 UNFCCC Conference (COP27) in Egypt to provide financial support to regions suffering both economic and non-economic losses caused by climate change.
- India has suffered over \$56 billion in damages from weather-related disasters between 2019 and 2023. Despite this, India has prioritised mitigation activities over adaptation in its National Climate Action Policy and budgets.
- Adaptation and loss and damage needs are more acutely felt at the ground level by State governments.

Consequently, it is the State governments that often bear most of the financial burden for disaster recovery efforts.

Can Kerala Access the Loss and Damage Fund?

Understanding the Loss and Damage Fund

The Loss and Damage Fund (LDF) was established at COP27 to provide financial assistance to regions
affected by climate-induced losses. However, accessing these funds can be complex, especially for
subnational entities like Kerala.

India's Role in Climate Finance

India has suffered significant damages due to climate-related disasters but has primarily focused on mitigation rather than adaptation. This focus has limited its engagement in Loss and Damage dialogues. India needs a clear legal and policy framework to streamline climate finance, particularly for adaptation and loss and damage.

State Interventions in Kerala

 Kerala has borne the brunt of disaster recovery costs, as exemplified by the Rebuild Kerala Development Programme. However, the lack of a standardized assessment process for disaster-related damages hinders access to the LDF.

Challenges and Opportunities

 Kerala and India face challenges in accessing and managing climate finance, particularly for loss and damage. By establishing a domestic policy framework focused on locally led adaptation and clear guidelines for accessing LDF funds, India can better protect itself from the impacts of climate change. 06/09/2024 Friday — September =

IN CHINA-AFRICA SUMMIT, XI PLEDGES \$50-BN FUNDS, HELP FOR JOB CREATION

Xi Pledges \$50 Billion for Africa

At the China-Africa summit, Chinese President Xi Jinping announced over \$50 billion in financing for Africa over the next three years. More than 50 African leaders and UN Secretary General Antonio Guterres attended the forum in Beijing, where Xi emphasized deepening cooperation in infrastructure, agriculture, and trade.

Key Financial Commitments

Xi stated that over half of the funds would be in credit, with \$11 billion in various forms of assistance

and \$10 billion in investments from Chinese firms. Additionally, he promised to help create one million jobs in Africa.

Military and Security Support

China will provide \$141 million in military assistance, train 6,000 military personnel, and 1,000 police officers from Africa.

Strengthening China-Africa Ties

UN chief Guterres highlighted that growing China-Africa ties could drive the renewable energy revolution. China, Africa's largest trading partner, continues to invest in the continent's natural resources and infrastructure development.

Hasina Ousted Amid Uprising

A student-led movement in Bangladesh ousted Prime Minister Sheikh Hasina on August 5 after weeks of protests over government jobs turned into a nationwide revolt. Over 600 people were killed in the clashes, and Hasina, 76, fled to India.

Yunus Takes Charge

Nobel laureate Muhammad Yunus formed an interim government, pledging to restore peace, fight corruption, and prepare for elections. His Cabinet includes two student leaders and aims to overhaul public

institutions, including the Election Commission.

Ongoing Unrest

Despite a return to normalcy, unrest lingers. Garment workers demand better wages, and Hasina, facing murder charges, remains in exile. Cases against her associates have sparked fears of politically motivated "vigilante justice."

Economic and Political Challenges

Although universities have reopened, student attendance remains low, and the economy is struggling after weeks of shutdown. Yunus has asked for patience, as some call for his government to remain until meaningful reforms are enacted, while others urge swift elections.
